your home. Once you have one, practice, practice and practice some more. Why? It could save your life.

My theme song for the year is Willie Nelson's "On the Road Again", as I am leaving to return to Chicago to work at the country's largest medical show as member of a large security management team. Each event is a learning experience, because we provide the client with direction for making the event safe for the attendees and employees. We begin by being prepared by coordinating with the local and state emergency responders to ensure that there is open communication and we all use the same procedures and common language in case of an emergency. We receive available information regarding any possible threat from local or international groups and put together contingency plans in case of a perceived or actual threat to the event or the venue. In doing approximately fifteen to twenty large events a year at different convention centers around the country, our security organization does not have the luxury of getting complacent. I believe this holds true for each one of you professionals in your workplace or workplaces depending on your scope of duties.

You need to make sure that you ALWAYS coordinate with the local emergency responders, to review your Emergency Response Plans, and hold drills to make sure that are viable and will work in different scenarios. This reduces your stress when something bad happens as you will know what to do and how to do it.

I hope you will plan on attending this next meeting and as a reminder there will be no July or August meetings. I want to leave you with one thought, "BE PREPARED, something bad happens every day"



The Reno Police Department has seen a reduction of fatal accident from 2011 to 2012. The Traffic Division investigated a total of seventeen fatalities for the year of 2011. From January - March of 2011, the Reno Police Department

investigated six fatal accidents. So far for 2012 the Traffic Division has only investigated two fatalities.

This brings the total of fatal traffic accident investigations for the Reno Police
Department from January 2011 to present to nineteen. Of those nineteen investigations ten involved alcohol or drugs in either the driver or victims
